Project Description

In keeping with commitment to their vision, the CPS Energy and Sustainability Program engaged the Peoples Gas Energy Efficiency Program to identify opportunities to save energy. The partnership kicked off in 2018 with a focus on boiler tune-ups. By March of 2020 more than 360 boilers were improved at 180 school locations, all fully-funded by the utility program. The completed projects helped improve boiler efficiency, reduce energy costs, lengthen equipment life, and prevent mechanical issues that could lead to costs for major repairs or replacements.

These successes have enhanced the collaborative relationship between the CPS Energy and Sustainability leadership and the Peoples Gas Energy Efficiency team. Together, they have developed a two-year plan, which could save up to five million therms - a meaningful contribution toward CPS' sustainability goals.

Impact

The CPS Energy and Sustainability Program has saved the school district 984,735 therms since 2018 and received \$634,688 in incentives to support project implementations from the Peoples Gas Energy Efficiency Program.
